# PREPARATION INSTRUCTIONS FOR AN INTERIOR MITE SPRAY TREATMENT

# THE FOLLOWING PROCEDURES MUST BE COMPLIED WITH IN ORDER TO SERVICE YOU OR YOU WILL FORFEIT THIS SERVICE AND BE CHARGED ACCORDINGLY.

## PREPARATION REQUIREMENTS:

We require you to be out of the apartment/unit for a minimum of 3 hours after a spray treatment in order to allow the treatment to dry. Pets i.e.: cats, dogs, and birds should be removed from the unit treated as well. Fish tanks should be covered and the pump turned off during the treatment. You are also required to complete the following preparations:

- Take all articles off the floor areas (closets included)
- Launder bedding after treatment
- Vacuum floors before and after treatment and throw the vacuum bag away each time
- Do not shampoo carpets/floors for at least 30 days

The chemicals are a direct contact material, which means that the pest has to make contact and then slowly dies. The material will be effective for 30-60 days, which will also affect further re-occurrence.

Please notify the manager if you are unable to meet these specific requirements at least one day prior to your appointment. If you have any questions, please contact your community manager.

Registration is granted when the state finds that, based on existing scientific evidence, there are no appreciable risks if proper use conditions are followed or that the risks are outweighed by the benefits. The degree of risk depends upon the degree of exposure, so exposure should be minimized.

### **ANTICOAGULANT REACTION:**

If Rodenticide ingestion occurs, you may experience symptoms of mild shock or bleeding.

### **PESTICIDE REACTION:**

If within 24 hours following application you experience symptoms similar to common seasonal illnesses comparable to the flu, contact your physician or poison control center and your pest control operator immediately.
